

# **Greetings Brethren:**

It has been quite a while since we last published a newsletter. An extended time, that has included a lot of big world drama and not a small amount of local drama that involved Birmingham 44. As I'm sure you are all aware, we sold our property in late 2020, and moved to the Masonic Temple in Detroit – which would be a big enough story – but a little global pandemic somewhat overshadowed it.

There may still be many members, especially our out-of-state members, that are unaware of the circumstances of the sale and of the move, so I'll provide a brief synopsis. First of all, it should be stated, there were no members that I know of that wanted to sell the lodge. It was a beautiful building on a very nice piece of property in an ideal location. We moved to that location in 1964, and had had a lot of success and great experiences there. While Birmingham #44 has moved before and has had several locations over the 170 years of its existence, the bottom line is that, financially, we could no longer stay at our location. We would have bankrupted our assets, lost the property anyway through tax forfeiture and foreclosure, and possibly lost our Charter in the process. For Birmingham #44 to survive, we had to sell and move somewhere else.

We had what could be referred to as "the perfect storm" of unfortunate events that led to this. The building was aging and falling apart. Our roof was failing and water was leaking into the building -- it had gone past repair and needed replacement. The electrical and HVAC ran through the roof, so it all would have had to be replaced. At the same time, all of our HVAC units were at the end of their lifespans and needed to be replaced. Our parking lot needed to be replaced and we needed extensive plumbing work. Quotes on repairing all this far exceeded our total assets and investments. Our membership dues income did not even cover our property taxes. At the same time, our rental income – which we depended on to pay taxes, maintenance, and building repairs had fallen sharply off. Part of this was due to the condition of the building, but also due to the building being very outdated – it still looked like 1964. The final straw came when we found out our primary, long-term renter was looking for another location.

All of this contributed to our decision to sell, but we also looked at our finances and realized that we weren't able to perform one of our basic tenets of Masonry – Charity – as fully as we wanted to. Bringing the Lodge back to sound financial health would allow us to make more charitable donations to help our surrounding community and to build endowments that could be used for scholarships. Spending all the time and effort in trying to save a building had taken us away from why most of us had joined Masonry. We realized that a building didn't define who we were as Masons, nor did it define who we were as Birmingham #44 Lodge.

In 2014, the Lodge voted to allow the Temple Board to explore bids for the property. We initially had a few interesting offers that would have allowed us to stay on the property, while selling the majority of the site to a developer. The City of Bloomfield Hills, unfortunately, shot all these ideas down. This process took years, but we finally sold the entire property to another developer, closing in late 2020. There were many legal complications before closing – including a small part of the property belonging to an Indian tribe in Arizona (long story) — but it all eventually was resolved.

At our January 2020 business meeting a vote was taken to move to the Masonic Temple in Detroit, as the new location of Birmingham #44. The Masonic Temple is a grand building, and one of the largest and most impressive Masonic buildings in the world. The vote passed 44-1.

Two months later, the second part of our Perfect Storm hit: The Covid 19 Pandemic. This complicated the sale and the move downtown, but worse, it complicated our efforts in transitioning our members to the new location. Lodges were not allowed to meet for quite a while, and when this restriction was lifted, many members were still reticent about getting together in groups. Covid is still a concern as of this writing, and we are still struggling to bring back some of our members to lodge.

Fortunately, things are improving, and many members are discovering what a great facility the Temple is. We have been bringing in new members, and WM Jack Palmer has been doing a great job on getting us back on track. Some are concerned about the longer drive, and there has been a push to find another facility soon, back in the Birmingham area. Brother Zane Kadro is heading up that initiative. In the meantime, we meet in the Tudor Room on the third floor. The Masonic Temple is located at 500 Temple Street in Detroit. Parking is behind the building. The lot can be accessed off 2<sup>nd</sup> Ave, down the alley, between the buildings.

The 2000 film, "The Perfect Storm", is based on a true story of a combination of weather patterns in 1991 – a convergence of a Nor'easter with a tropical hurricane – that created havoc on the East Coast, manifested 100 foot waves, and spelled doom for an unfortunate fishing crew. Birmingham #44 has faced its own "perfect storm" in the last couple years, and while we were jostled and tossed – and also ended up a little wet (mostly from our leaking roof) – we came through these storms in one piece, ship-shape, and ready to face the next 170 years.

## From the New Building Committee,

Finding our new home has certainly not been without challenge. From lease to buy to rent it seems like everyone has their own opinion on what we should do. My goal here is to provide you with all the information you need to vote at the June business meeting on a resolution that will enable us to buy a building.

First, we combed through about 100 listings in the efforts to lease a commercial space and build out a proper lodge room. We focused on Birmingham and cities adjacent to it. The Lodge toured one building in Birmingham that was \$5000/mo, but the reactions from the brothers were mixed. The landlord quoted us around \$200,000 of build out and wasn't willing to share the cost even with a 10 year lease. We determined at that time that renting in a commercial space in proper Birmingham was going to be extremely challenging.

Next, we started looking for purchase options. Unfortunately, there wasn't anything in our price range, and anything that came up that was, disappeared within days in this seller's market. We determined we need about \$300,000 to build out a proper lodge room and create a second entrance for a rental property. We found a building that was perfect --we could have paid cash and still had plenty of money in the endowment. We tried to get this under contract, but the building sold 3 days later for \$650,000.

Lastly, we engaged the Berkley lodge to secure a weekly rental, but the Eastern Star and Rainbow girls meet on Thursday nights and they were unwilling to switch to Tuesdays.

Moving forward we are focused on finding a building within our price range including buildout. For us to do that we need to have authorization from the lodge for the following:

I am asking the lodge to vote on a resolution that would give the new building committee along with the president of the finance committee and the WM the authority to put a building under contract with a \$50,000 Ernest Money Deposit and 45-day due diligence period. The day the building is put under contact we will send out a meeting time for the whole lodge to come and see the building within the first 7 days. After the meeting we will have a vote to either proceed with due diligence or terminate the contract and get our deposit back. If we continue with due diligence and the same committee that placed the building under contract determines that we can afford it and that the repair and retrofit budgets are cohesive with the perpetuity of the lodge we will vote to move forward with the purchase.

I hope to see you all at lodge this week.
